RE: Small Capital Improvement Program for 2024-25; Proposals Due July 8, 2024

I am pleased to inform you that we will once again be considering projects for funding in 2024-25 through the Small Capital Improvement Program. Projects submitted for consideration should meet the following criteria:

- Accommodate new faculty hires
- Improve instructional space
- Correct critical life-safety deficiencies

Due to the fiscal challenges the campus is currently facing, funding for 2024-25 program will be limited. Please be mindful of this limitation and submit only your top two priorities. To assist with maximizing available funds, preference will be given to projects that include matching funds of 25% or more.

In the interest of expediting urgent projects, units may, at their own risk, use departmental funds to initiate work on their highest-priority projects prior to receiving funding approval. If the project is approved, budgeted expenditures incurred prior to approval would be reimbursed as part of the award. Guidelines for prefunding and reimbursement of SCIP projects are provided in Attachment 1.

Please use the attached Project Summary Form for submitting your proposals. Detailed instructions for submitting proposals are included on the form. Contact the following people as appropriate for assistance in coordinating project proposals:
